General Rules

IMPORTANT - PRIVACY MATTERS

Participants in this competition understand and agree that for us to offer this competition, we may collect and use personal information about participants. This personal information may include your first name, last name, email address, mobile number, ID number and in certain instances your image. - DA must receive your entry before the published closing date and time. DA must also receive your entry in the
 correct format. You will lose the right to take part or claim any prize that may have been awarded to you if you
 don't enter on time or in the correct format.
- If DA is not able to get hold of you after making reasonable efforts to do so, DA can award the prize to someone
 else. If you don't claim your prize on time, you will lose your right to any prize.
- If you are in breach of these rules, you will be disqualified and you will lose your right to any prize(s).
